THE NEW CHAPEL IS OPEN!

Scecina opened the doors of the new chapel for the first class Mass on Sept. 28. **Father Rick Ginther**, pastor of Our Lady of Lourdes Parish and dean of the Indianapolis East Deanery, was the celebrant for the Mass attended by the Class of 2023. Several seniors supported the Mass as lectors, altar servers, and Eucharistic ministers.

"It was a great experience as I felt like I was a leader being one of the first readers in the new chapel. It was a great environment to be in and made me feel closer to God. I would strongly consider others to do it as well. As it helped me step out of my comfort zone and can do the same for others. The chapel was a great addition to the school. It allows everyone to have a private place to connect with God," said senior **Adam Young**.

The new space was designed by Entheos Architects in concert with Scecina leadership and was approved by **Most Rev. Charles**

C. Thompson, Archbishop of Indianapolis. The chapel seats up to 140 people and houses a confessional room to support students and staff to receive the Sacrament of Reconciliation.

Wurster Construction, the construction manager for the project, began demolition on two rooms on the main floor that previously housed the Scecina Spirit Shop and the staff workroom. The Spirit Shop and staff workroom were relocated to another area of the building. The wall between the rooms was removed to create the new chapel space.

To maintain a historical and symbolic connection with the school's heritage, many refurbished items from the prior chapel in Saint Francis Hall (the former convent) are in place in the new chapel – the crucifix; tabernacle; Stations of the Cross; marble for the altar, pulpit, and tabernacle base; and statues of Mary, Joseph, and the Sacred Heart of Jesus. Completing the new chapel construction at Scecina is another

step in the **Our Faith, Our Journey, Our Time** capital campaign and creates a beautiful sacred space that provides an inspiring reminder of the presence of God in our lives. The pledge total for Scecina's capital campaign stands at \$7.26 million.

"This new chapel stands as a tribute to the vast generosity of Scecina's alumni and friends, the importance of our students' spiritual lives, and the talents and insights of our design team and everyone whose input contributed to this sacred space," said Scecina President **Joe Therber**.

Groundbreaking for two more capital campaign projects – the new athletic fields and front entrance renovation – is now planned for Spring 2023. Scecina also is funding Academic Excellence and Facilities endowments through the capital campaign.

FATHER TOM DAY MASS RETURNS

Father Tom was a priest with the Archdiocese of Indianapolis who served God and his country as a military chaplain during World War II before perishing at sea with other U.S. prisoners of war in 1944.

This event was tragic but also serves as a powerful example and reminder of Christian faith in action.

On Nov. 9, Seccina faculty, staff, students, alumni, veterans, and friends, honored Father Tom at our annual Father Tom Day Mass. **Toni Leffler, Judy Neidlinger, Judy Nichols, and Barbara Riley** were all presented with the Father Tom service award for their countless contributions to Seccina. ALL IN THE FAMILY

This past August, while most seniors were excitedly returning to Seccina to start their final year of high school, **Marcus Greathouse** was hard at work finishing his basic training with the Army Reserves in Fort Jackson, South Carolina. Marcus graduated from basic training on Sept. 1.

For Marcus, there was never any hesitation in his choice to enlist in the U.S. Army Split Training program. Marcus is raised by two U.S. Army veterans, including his mom, **Nancy Greathouse**, a Spanish teacher at Seccina.

“My parents inspired me to enlist, but I also wanted to better myself by learning the Army values,” said Greathouse.

Because Greathouse attended split training during the summer before his senior year, he’s well ahead of most high school students who join the military. The split training program allows high school students to enlist while they are juniors, are 17 years old, and have permission from a parent or guardian.

Marcus has two goals after he graduates from Seccina; to attend the U.S. Military Academy at West

Point and complete The Reserve Officers’ Training Corps. (ROTC) program. Upon college completion, Marcus can continue to serve in the Army or as a reserve soldier.

“I feel very proud to be a veteran and Army mom. I know that Marcus will be taken care of for the rest of his life. The Army is a family; once you become a soldier, you are part of the family forever,” said Nancy. ■

GAVIN TURNER SAYS YES TO JORDAN

Gavin Turner, a junior from Scecina, was awarded a Youth Exchange and Study (YES) Abroad scholarship for the 2022-23 school year. The merit-based award covers the full cost of an academic year abroad, providing Gavin a full immersion experience, including living with a host family in Jordan, attending a Jordanian high school, and helping him develop the skills necessary to be a leader in the global community. The YES Abroad program is funded by the U.S. Department of State's Educational and Cultural Affairs Bureau.

Gavin is one of only 65 students selected competitively from across the United States who received a scholarship to participate in the Kennedy-Lugar YES Abroad program.

We interviewed Gavin about what he's experienced so far.

Q: How was your travel and arrival? Any challenges or things you learned along the way?

Travel was pretty easy; I took a quick flight to D.C. before taking a 13-hour flight directly to Amman. The hardest part was honestly being thrown in so quickly, and the jet lag, of course, but when you are forced to adapt, it comes naturally.

Q: Was it love at first sight when you landed?

Landing was cool because you cross into Jordan, and suddenly a huge city that goes on forever appears in front of you. It was definitely the moment that I felt this was the right thing to do.

Q: How have you adapted to the culture?

I had to get used to learning a language I had no prior experience with, but luckily Jordan has a pretty large population of people who speak English, so I've been able to ease into it. In terms of culture, it hasn't been big things but just shifts. For example, meals are typically eaten later here, and the weekend is Friday-Saturday rather than Saturday-Sunday as it is in the States.

Q: What's it like living with a new host family?

It's been honestly really good! It's been hard not to be around my family in the U.S. every day but having people here who treat me as part of the family has helped me to settle in quickly.

Q: Have you had any challenges as you get acclimated to school?

Yes, the school is run through an International Baccalaureate program, so I had to learn what that means. The classes are challenging, and not having friends I've known for years to help with work is also not the best, but the school's culture is excellent, and I've felt incredibly welcomed into the community.

Q: When not studying, what do you do for fun?

When I'm not studying, I've been exploring the city and going to malls. Amman is super pretty and has very nice neighborhoods that allow you to see both the old and the new. For example, while I've been here, I've seen ancient ruins from Roman times and super modern shopping malls and skyscrapers. Speaking of malls, they are incredibly popular and well maintained here, making them an ideal place to walk around.

Q: How do you connect with friends and family at home?

It's been tricky because of the time change and being careful with data usage, but I call my mom every day to talk. I have reached out to multiple friends on social media when they've asked how I'm doing or when I want to share something with them.

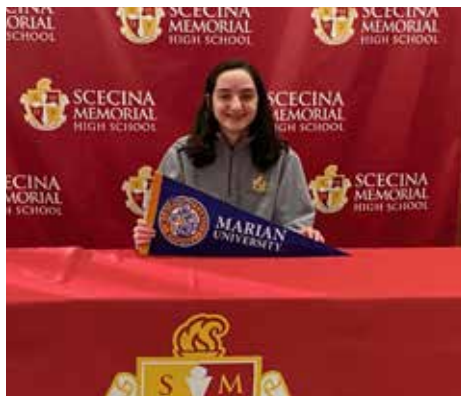


SAINT MARY ACADEMIC SCHOLARSHIP

CRUSADER VOLLEYBALL ADVANCES TO SEMI-STATE, SETS SCHOOL RECORD

Led by seniors **Isabelle Comely**, **Allison Daves**, **Cierra Lathrop**, **Abbey McCoy**, **Anna Welborn**, and **Ella Wright**, the 2022 Crusaders achieved a 25-5 regular-season record, an appearance in the City Championship final, and captured Sccecina's fifth conference championship.

During the season, three Crusaders joined the 1,000 club. Junior **Natalie Bollenbacher** earned 1,000 career assists. Daves earned her 1,000th career kill and assist. Lathrop earned her 1,000th career dig. McCoy set a school record with 441 kills in a season and finished her career with over 1,500 kills.

The girls beat ICC rival Triton Central in the sectional

championship to earn a spot in the first round of regionals against Park Tudor and avenge a loss from earlier in the year. Later that evening, the Crusaders defeated Northeastern in three sets to win the first regional championship in school history.

On Oct. 29, the girls traveled to Jasper High School to play in the semi-state game against Linton-Stockton. Through a hard-fought, five-set match, the Crusaders dream of making it to a state championship fell a step short. The girls finished the season by setting a school record with 30 wins.

Dan Hagist, class of 1970, returned as head coach of the Crusaders. Hagist previously coached at Sccecina from 1994-97. With the

success of the 2022 season, Hagist improved his career record to 409-205 (115-40 with the Crusaders). Hagist was named the Class 2A Central Coach of the Year. When asked about the season, Hagist shared, "The girls worked hard during practice and kept their focus on getting better as individuals and playing as a team. Although we graduated a great group of seniors, our young players will be ready to step up and be competitive next year."

Hagist is correct, and a new group of Crusaders will step up next year, but the Sccecina volleyball team will long be remembered for their remarkable season reinforced by the impressive number of honors the players received (*see page 10*). ■

SEASON RECAP

CHEERLEADING

Coach Jana Montgomery

The cheer team had a wonderful fall season and were able to form a varsity and JV squad for the first time in several years. Seniors **Sonia Lockhart, Korionna Martin, Ana-Moreno Jerez, and Erionna Edwards** demonstrated great leadership. These fearless young ladies will excel in all their future endeavors. Our season was also filled with college-level stunts and cheers. One of our stunts gained social media attention with a growing 30,000 views.

CROSS COUNTRY

Coach Jon Benson '89

The cross country team is in a period of rebuilding. Head Coach **Jon Benson '89** was in his first season at Scecina after coaching 11 seasons at Holy Spirit. The team worked very hard at learning to practice with purpose and developing appropriate race strategies. These efforts resulted in tremendous improvement

throughout the season. Our 11 runners set 21 personal records. **Peter Certo** finished four places shy of advancing to Regionals. Five of our 11 runners are freshmen, so we are a young team with high expectations for next season.

We also excelled in the classroom. **Elizabeth Mattingly** and **Matthew Hentz** earned Academic All-Conference honors while **Alex Benson** was Academic All-Conference as well as Academic All-State.

FOOTBALL

Coach Ott Hurrle '70

Led by senior captains **Mason Beriault, Calvin Connor, Keaton Thibo, and Tamir Woods**, the Crusaders earned a 10-2 record and a sectional championship appearance. The 10-win season was only the 11th time in Scecina's 69-year football history that a team accomplished double-digit wins and only the third time in history to accomplish double-digit wins in back-to-back seasons.

Five seniors finished their Scecina career in the top 50 in career tackles for the Crusaders: Beriault – 6th, Woods – 13th, Connor – 35th,

Adam Young – 37th, and Thibo – 45th. Behind strong tackling, the Crusaders had four shutouts on the season, which gave them 10 for the past two years and broke the previous two-year record of seven shutouts set in 1955 and 1956.

During a Cardinal Ritter game, Young made a tackle for a loss (TFL) which broke **Jason Jacobs '96** record of 56 career TFL's. Adam finished his career with a Scecina record 70 TFL's and Woods finished second with 65 ½. During the final game of the regular season at Monrovia, **Carter Nolan '23** made an extra point that was the 15,000th point scored in school history.

BOYS SOCCER

Coach Garry Adams '96

This season was a vast improvement from last year. The boys scored goals early and often. The season was led by our top scorer, first-year **Oliver Carrillo**, who finished the season by earning MVP and was a member of the All-Conference team. The future is extremely bright for this team, as all goals were scored by freshmen. With another year under their belt, this team will go far.



GIRLS SOCCER

The girls' soccer team finished with a record of 4-9-2. The number of players increased from 16 a year ago to 34 players this season. This enabled the development of many younger players through a JV team.

Ava Smith: Led the team in scoring this year. This team captain was also selected to the All-ICC team. She was a leader on the field and created her own shots from anywhere. She was named Scecina's offensive player of the year.

Jimena Quintana: She's a hard worker who was nonstop while on the field. Created a lot of havoc for the opponents.

Aylee Gomez: Her hustle created many opportunities on the offensive end of the field. She was a splendid example for our younger players of getting the most out of your ability.

Paola Esparza: Another hustler on the field. "Payday" used her speed to put pressure on the defense.

Chelsea Aragon: A threat anywhere on the field. She anchored our midfield. She was one of the team's

top goal scorers. She had great touch and was a pre-session passer.

Dania Ruiz: Captain and outside mid. Another workhorse, who logged the most minutes on the team. She was always trying to be the spark and an example to get the team going. She was awarded the team's Mental Attitude award.

Emily Gonzales: She scored three goals, the first of her career. The most memorable was her amazing header against Shortridge. She won the team's Hustle Award given to the player who never gave up.

Alice Santos: First year playing. She showed tremendous improvement from day one to the end of the season. She scored her first goal on Senior Day!

Faye Eskew: First year playing. She was one of the fastest players on the team. Unfortunately, her season ended early due to injuries.

Shantel Castellanos: Her first year playing. She was such a positive person at practice. She was a solid JV player.

Katherine Guerra-Cordova: Another first-time player. She played JV and was a tremendous

defender. She was also a pleasure to have at practice.

BOYS TENNIS

Coach Jerry McCarty

The Crusaders record for the 2022 season was 9-6. The team was led by a solid performance of their six seniors. The team won the Speedway Invitation with the following earning individual medals: Number two singles **Quinn Schreiber '23**, number three singles **Jakob Kehrer '23**, number one doubles **Kyle McDonald '23** and **Teddy Waninger '23**, and number two doubles **Rafe Morris '23** and **Max Krause '24**. Number one singles player **Daniel Eljach '23** advanced out of the first round of the City Tournament. Schreiber went undefeated in ICC play and earned number two singles All-Conference honors.

During the first round of sectional play, the Crusaders lost a close match to Decatur Central. The number one doubles team of McDonald and Waninger won their match and advanced to the next round.



NATIONAL HIGH SCHOOL BASEBALL COACHES ASSOCIATION HALL OF FAME 2022

Dave Gandolph '68, head baseball coach for Scecina since 2014, was inducted into the National High School Baseball Coaches Association Hall of Fame at its annual conference in Sanibel, Florida.

In 43 seasons as a head baseball coach with a record of 822-409-6, he has enjoyed coaching hundreds of student-athletes. Over 100 of his players have played in college and seven have been drafted. His teams have won 17 Sectional titles, and several Regional titles and Conference Championships. In his first season at Scecina, in 2014, he was the ABCA Regional High School Div. 3 Coach of the Year.

This is the third hall of fame honor for Gandolph, who was previously inducted at his alma mater St. Joseph's College in 1988 and the Indiana Baseball Coaches Association Hall of Fame in 2008.

When asked about his thoughts on receiving the award, Gandolph replied, "I have been blessed throughout my career, and it's an honor to be back at my high school alma mater, where my passion for athletics began." ■

Hello, Scecina Community Members.

Just when you think that President Joe

Therber and his talented, skilled and dedicated faculty, administration, and staff have achieved unparalleled success, they reach an even greater level. The 2021-22 school year ended with another distinguished graduating class who received acceptances to over 50 institutions of higher learning. This class had to persevere with the disruptions and difficulties of COVID and passed with flying colors. These exceptional young ladies and gentlemen were supported in an outstanding fashion by the school's remarkable faculty and administration. To really appreciate the accomplishments of the last year, we have to look at how the 2022-23 school year began: 135 incoming freshmen and opening of year total enrollment at 471, both 21st century records. While efforts to increase enrollment were going on, so were the complexities of post-COVID, addressing the ongoing capital campaign requirements, and of course, maintaining the day-to-day operations in a safe and efficient manner.

Relative to the school's fiscal condition and as illustrated within this annual report, the 2021-22 year was a resounding success, with the surplus being allocated to needed cash reserves, which will be available to maintain the nearly 70-year-old property. Keeping the school in the best condition possible is a top priority and with the current historically high inflation

levels, compounded by labor and material shortages and supply-chain disruptions, the administration is challenged on a daily basis, from a cost/benefit perspective, to acquire the necessary materials, supplies and utilities. The really good news from a financial perspective is that the development team was able to generate almost \$1.2 million from donations and fund-raising events during the 2021-22 fiscal year. This significant amount resulted from the hard work and dedication of these exceptional people, and of course the loyalty and generosity of you, the remarkable Scecina community. Thank you!

During this calendar year, the new chapel was completed. As a combined endeavor, the athletic fields upgrade and the front entrance renovation will begin during 2023. Both of these projects will be transformative and a major enhancement to the school's campus appearance and utility.

In closing, I want to once more offer congratulations and a very heartfelt "thank you" to President Joe Therber and his truly outstanding faculty, administration, and staff for another job "well done". And on behalf of the Board of Directors and Scecina Memorial High School, I want to thank you, the Scecina community, composed of our students, families, alumni, business partners, friends and loyal Crusaders everywhere.

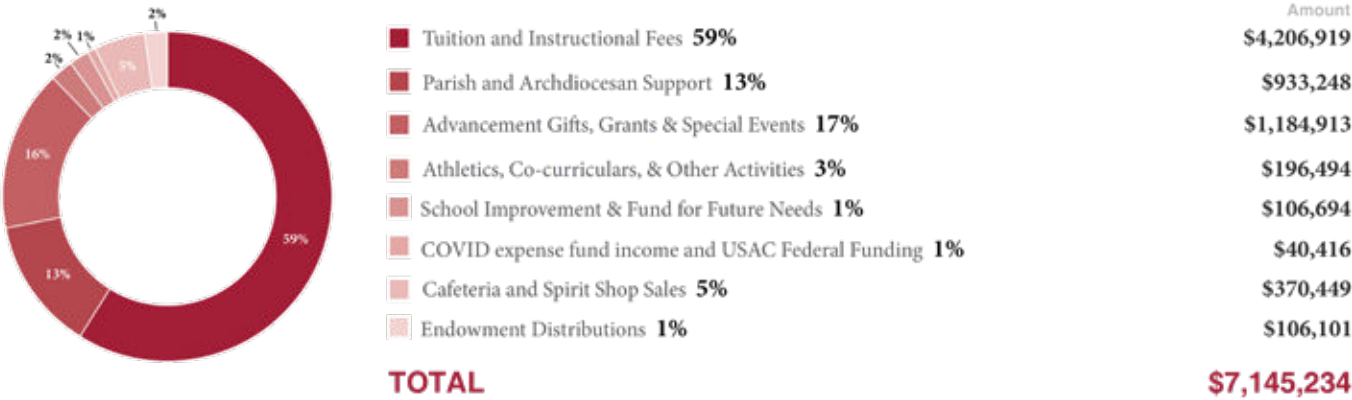

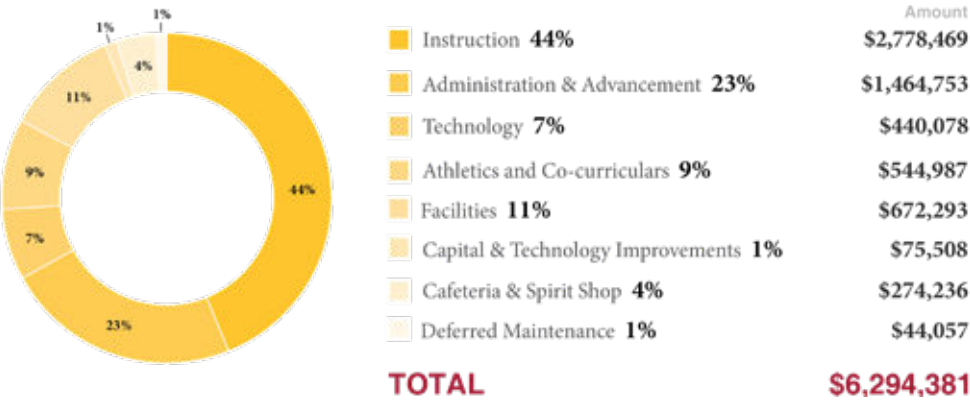
2021-22 OPERATING REVENUE AND EXPENSES

2021-22 OPERATING REVENUE



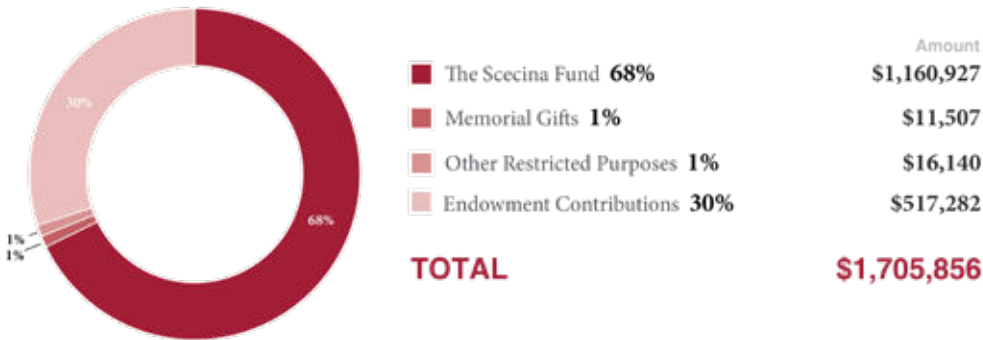
2021-22 OPERATING EXPENSES

PARK NAMED AFTER SCECINA ALUMNA KATHY STEELE

Class of 1966 graduate **Kathy (Shaver) Steele**'s 42-year career in Crawfordsville Community Schools, including 13 years as superintendent, inspired city officials to name a park after her when she retired.

Why does she work so hard on behalf of Crawfordsville children and the community? She quickly tears up a bit in response: "It all started at Scecina and the motto to 'give that little extra.'" She strived to earn her letter jacket. Her older brothers, **Jim '60** and **David '62**, earned letter jackets by participating in varsity sports, unavailable to Scecina girls at the time.

"Absolutely nobody has ever fought harder for the children of our community," Crawfordsville Mayor **Todd Barton** said of Steele at the 2021 ribbon-cutting ceremony for the Kathleen J. Steele Park.

The park features playground equipment, a basketball court, shade trees, benches, cornhole, and picnic tables. All ages can share the basketball court, because there's a lower basketball goal on one end for the younger kids and a higher one for the bigger kids.

After teaching at Indianapolis Public Schools, Kathy was recruited

by Crawfordsville schools in 1972. She started a program for gifted and talented students, one of the first in the nation, and was a national leader in the field. She has written a book, "Involving Parents," and co-written another, "Creative Teaching." She also has led efforts to improve school nutrition.

She was coordinator of gifted education and the gifted education model site director for 10 years and coordinator of curriculum and innovation for six. In 2001, the Crawfordsville school board chose her as its superintendent. One of her legacies is the Crawfordsville Middle School. She knocked on doors herself to convince residents to vote for the referendum to build the school, which passed with nearly 80 percent approval.

"During three decades of covering news in our part of Indiana, I've interacted with dozens of school superintendents," said her Scecina classmate **Mike Piggott**, a longtime Lafayette, Ind., radio newsman and later Purdue's director of community relations. "Kathy Steele is a class act and, certainly, one of the most respected. Even as an administrator, Kathy was first a teacher, and that approach served the Crawfordsville community well."

Beside her through all of it was her dedicated husband, **John Steele**, a

1962 Scecina graduate who died in April 2021. "He was a good guy," said Kathy. The couple was tickled when the Crawfordsville Main Street Board of Directors honored John with a trash can and plaque. It complemented the nearby park bench installed in Kathy's honor in Marie Canine Plaza at Crawford Place. The bench is inscribed: "In honor of Dr. Kathleen J. Steele, dedicated and skillful educator who encouraged others to lead."

Kathy, who is a member of the Scecina Women's Circle, continues to give back to Crawfordsville, currently serving as the local United Way campaign chairman. Although Kathy has earned local and national awards and distinctions as an educator, she proudly points to a special one on the wall of her home: Distinguished Alumni Award, Little Flower Catholic School, 2016.

"Little Flower, Scecina, and my parents were the building blocks that shaped my future," she said. "I feel fortunate. I've had a great life." ■

ANDREA SLOAN BREAKS GROUND IN MALE-DOMINATED INDUSTRY

Andrea (Caric) Sloan, who graduated from Scecina in 2000, is a rising star in Indianapolis' business community. She is the president and owner of GroundBreakers, a certified woman and veteran-owned business enterprise that performs non-destructive and precise hydrovac excavation services.

GroundBreakers' mission is to safely and efficiently remove soil around buried utilities and underground structures. The hydrovac excavation process from GroundBreakers combines pressurized water and a mighty 6000 cubic feet per minute positive displacement blower system that allows excavation in the most challenging conditions, including frozen ground. OSHA approved the soft dig method used by GroundBreakers, where mechanical excavation is not permitted as the safest non-destructive method of digging.

In March, the Indianapolis Business Journal (IBJ) recognized Andrea as a member of its Class of 2022 "40 Under 40," the IBJ's yearly list of local business and professional leaders who have achieved success and excelled in their field before the age of 40. She's a rare woman business owner in the male-dominated construction world.

As a U.S. Army Reserve veteran, she actively recruits veterans to her business. In 2021, GroundBreakers won a HIRE Vets Gold Medallion

Award, a U.S. government program recognizing employer efforts to recruit, employ, and retain veterans. This November, her company was named Certified Vendor of the Month by Mayor Joe Hogsett and the City of Indianapolis' Office of Minority & Women Business Development for their efforts in supporting veterans in the Indianapolis community.

Andrea also is enthusiastic about encouraging other women and veterans to pursue business ownership. "When I walk into a room, I am still very much in the minority," she said.

She sits on the board of the Indiana Construction Roundtable and is a member of its diversity and equity committee. The effort is designed to empower owners, general contractors, construction managers, and XBEs contractors in achieving a new level of engagement resulting in improved business relationships, greater diversity and inclusion, and education on challenges faced by business owners representing diverse communities.

Andrea, a lifelong Indianapolis area resident, is devoted to giving back to the community by volunteering for Habitat for Humanity Indiana. GroundBreakers has recently helped support a home build on the city's Eastside and has committed to supporting future builds. Andrea is also an active board member of Homeless Veterans and Families. This organization provides housing and reintegration services for homeless veterans and programs to prevent at-risk veterans from becoming homeless.

She received and took to heart great advice from a woman mentor, "Don't turn down opportunities, take them on, because you never know where that yes is going to lead you." She said that her ability to work hard and take risks and her "growth mindset" are her strengths. "Build the most extensive network you can that will encourage and support your journey."

Andrea is a part of the Indianapolis chapter of the National Association of Women in Business Owners, the National Association of Women in Construction, the Indiana Subcontractor Association, and the Young Presidents' Organization.

"I have learned so much from my network that has helped me operate a business and take measured risks," Andrea said. "To be honest, owning a business is very stressful, but I wish I could have taken the leap earlier in life." ■

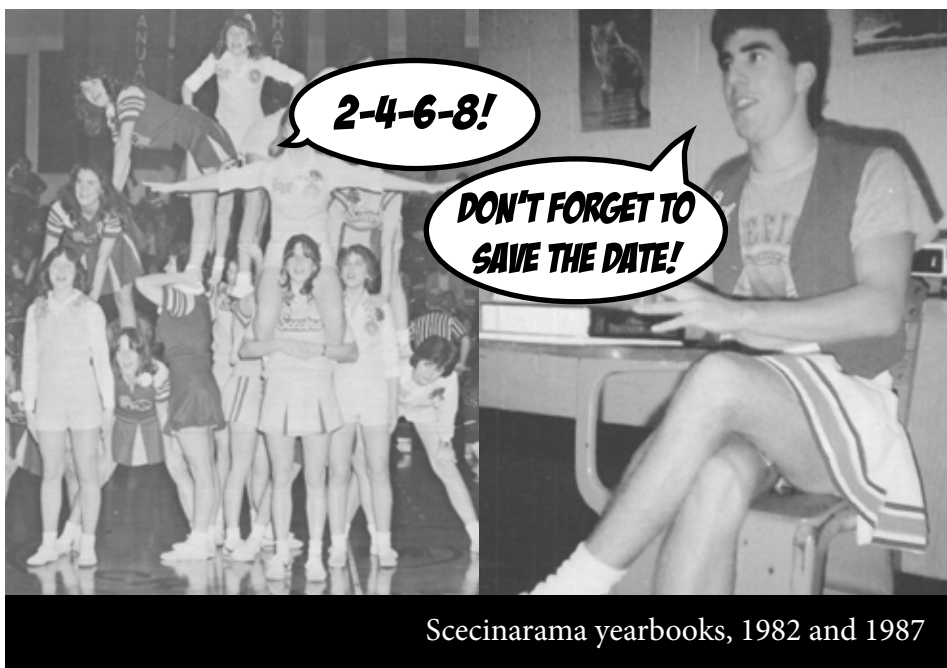
"It was nice to get together again for an Advent outing," said **Amy Begley '93**, SWC chair.

\$500,000 GIFT ESTABLISHES THE FIRST RESPONDERS TUITION ASSISTANCE ENDOWMENT FUND

In October 2021, a very generous Scecina alumnus and his wife called and said that they anonymously wanted to touch the lives of Scecina students who are children and grandchildren of first responders. The couple also said that the way in which they wanted to accomplish this goal was to make a \$500,000 gift to Scecina to set up a permanent tuition assistance fund for Scecina students. This fund, which is in its first year of existence, is named the First Responders Tuition Assistance Endowment Fund.

The fund defines first responders as policemen/women, firefighters, Emergency Medical Technicians, nurses, and active, inactive, and retired members of the United States military services. The three criteria that are used to make

grants from the fund are child or grandchild status of a first responder, family financial need, and overall good standing at Scecina.

When asked what moved them to such kindness and generosity, the donors affirmed the life-changing and life-saving work of first responders, as well as their belief that all children, regardless of family financial resources, should have the opportunity to receive a Scecina education.

Recently, several Scecina teachers described the quality of students who are receiving tuition assistance from the First Responders Tuition Assistance Endowment Fund this year. A representative teacher testimonial about a student

recipient is that he is “a great young man and an amazing student. He has a strong work ethic and always goes above and beyond. He is incredibly intelligent. His insights help the rest of the class move forward with our lessons. He’s also very calm, observant, and able to adapt and go with the flow. He is always willing to help other students when asked. Outside of his performance in my class, he has a great personality and goes above and beyond to show kindness to others.”

Scecina thanks the anonymous alumnus and his wife for their inspiring generosity, which is making a difference for our young people through the First Responders Tuition Assistance Endowment Fund. ■

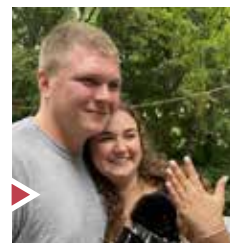
Sean Murphy '16 and Lucero Rodriguez '19
